7:25	 PRESENTATION: YAVAPAI COUNTY VERDE CONNECT PROJECT Kristin Darr of Verde Connect will provide information regarding the Yavapai County Verde Connect Project and their consideration of a plan to construct a new north-south road in the area bounded by SR 260, I-17, Cornville Road and SR 89A. 7:25(19:30) Dan Cherry, Yavapai County Public Works Director, presented information. (Kristin Darr was not present.) Yavapai County applied for a Federal Build grant in the amount of \$25 million dollars. Out of 851 grant applications, they were one of 91 recipients awarded funding, and the only one in the State of Arizona. Mr. Cherry spoke about the steps involved and the project, which has been proposed since 1999. He also mentioned the website of www.verdeconnect.com where persons interested could find further information and could leave comments. 7:34(27:30) Vamshi Yelsellti of Jacobs Engineering spoke. He has been involved with this project since 1999. He directed the audience to a power point presentation and talked about the steps involved with the project and the need for it¹. He encouraged people to visit the website for information and input, and noted that the funds need to be spent between 2020 and 2025. 7:45(39:19) Mr. Cherry said that they do want input and offered to answer any questions. Councilmember Moore said that she has concerns about wildlife and habitat. 7:46(39:35) Mr. Cherry said that wildlife is a big part of this project and mitigation is a requirement. 7:47(40:31) Mansel Mathews, a citizen of Jerome, asked if there was a map showing the population
