MINUTES

ITEM 1: CALL TO ORDER/ROLL CALL

The meeting was called to order at 7:00 by Acting Chair Mark Venker. Mr. Dabney called roll. Present were Acting Chair Mark Venker, Brice Wood, Mike Parry, and John Schroeder. Staff present were Kyle Dabney, Zoning Administrator, and Jamie Vander Horst, Minute Taker.

ITEM 2: APPROVAL OF MINUTES: Minutes of March 13, 2017

Mr. Wood moved to approve the minutes of March 13, 2017 as presented. Mr. Parry seconded. All were in favor and the motion passed unanimously.

ITEM 3: PETITIONS FROM THE PUBLIC

ITEM 4: NEW STAIRWELL TO REPLACE OLD ONE - 228 DIAZ STREET

Mr. Dabney – The stairwell was in very bad repair – pictures were reviewed and Mr. Dabney approves of the design. Stair well is a safety hazard. John – width will be the same? – yes, will some of the rocks be removed at the bottom – yes. John Schroder motioned to approve, seconded by Mike Parry, the motion was approved unanimously.

ITEM5: SIGNS - 8 LOCATIONS FOR SUTTULE STOPS AND 2 ADDITIONAL PARKING SIGNS

Mr. Dabney presented the lay out and the colors to the boa Mr. Dabney did survey on color, choice – blue with white lettering. Only change was the high school – to put the sign on the fence. John Schroder stated that the purpose of the sign was to stand out from the other signs for people to notice the shuttle.

John & Kyle discussion of color about the color – being orange and white for the shuttle. Mark Venker suggested that the parking signs stay blue and white and that the orange and white would suggest a stop for the shuttle. There was a discussion about signs around town and that some were in disarray, and need to be cleaned up and uniform. Discussion of a sign on the side of the Van to relate to the shuttle same color.

Mark Venker suggested that the color be a darker orange with white lettering. Mike Parry seconded the colors of dark orange with white lettering. Motion was passed unanimously.
