Chair Phinney asked about the visibility of the deck and the lighting from the street above. She also asked how the lighting would be controlled, on at sunset off at dawn?

Mr. Smith explained that it would be low lighting and not bright, and on when they were outside.

Mr. Parry asked about the lighting and is concerned about the night sky. He believes the lighting might impede the night sky. He further explains how he has had to change lighting in his own home.

Mr. Smith said the lighting is yellow, covered and not glaring.

Mr. Wood asked how high up are the lights?

It was confirmed they are 70" tall.

Mr. Smith said he didn't want them to go higher.

Chair Phinney asked if the deck had been approved for pedestrian use.

Mr. Smith said it was engineered for a third floor in 1996. It has six inches of concrete and four massive beams holding it up.

Motion made by Mike Parry to approve the replacement of railing and installing lighting on roof-top deck. Second by Steve Pontious. Motion carried unanimously.
